**TITLE:** ADOPTION OF LOCAL LAW INTRO. NO. 11 - 81, PRINT NO. 1, TO ESTABLISH FEES FOR THE REPRODUCTION OF COUNTY TAX MAPS

**RESOLVED:**

1. That proposed Local Law, Intro. No. 11 - 81, Print No. 1, is hereby adopted without any change in language, to wit:

A LOCAL LAW TO ESTABLISH  
FEES FOR THE REPRODUCTION  
OF COUNTY TAX MAPS

BE IT ENACTED by the Board of Legislators of the County of Allegany as follows:

Section 1. PURPOSE.

The purpose of this local law is to establish fees for the reproduction of county tax maps pursuant to clause iii of paragraph (b) of subdivision 1 of section 87 of the Public Officers Law.

§ 2. ESTABLISHMENT OF TAX MAP REPRODUCTION FEES.

1. The following fees for thirty inch by forty-two inch blue line diazo prints of county tax maps on file in the county real property tax service agency office are hereby established:

- a. For the first two prints ordered at one time a fee of two dollars per print.
- b. For the next two prints ordered at the same time as the first two prints a fee of one dollar fifty cents per print.
- c. For the next ten prints ordered at the same time as the first four prints a fee of one dollar per print.
- d. For each print over the first fourteen prints ordered at the same time a fee of fifty cents per print.

§ 3. COSTS OF MAILING AND SHIPPING TAX MAPS.

law, the actual cost of postage or shipping charges for mailing or shipping such prints by public or private carrier shall also be charged.

§ 4. ADVANCE PAYMENT OF FEES AND COSTS.

All fees and costs required to be paid under this local law shall be collected in advance of the making and delivery of such prints by the county real property tax service agency and shall be paid to the county treasurer.

§ 5. AUTHORIZATION TO INCREASE TAX MAP REPRODUCTION FEES.

1. Commencing January 1, 1983, the director of the Allegany county real property tax service agency may thereafter by written order or orders increase each of the fees established in section one of this local law when said director determines in his sole judgment that increased costs for copying, paper, other materials and operator salaries justify such increase or increases. Notwithstanding the foregoing provisions, in no event shall any of the fees established in section one of this local law be increased to an amount which exceeds such established fee by one hundred per cent.

2. The order or orders increasing such fees shall be filed by the director in the office of the clerk of the county board of legislators and no increased fee or fees provided for in such order or orders shall take effect until thirty days have elapsed from the date of such filing; provided, however, that the director may establish in such order or orders an effective date for such increased fee or fees that exceeds such thirty day period.

§ 6. APPROVAL AND RATIFICATION FOR FEES AND COSTS COLLECTED.

All fees and costs in connection with the reproduction of county tax maps that have been established and collected by the county real property tax service agency prior to the effective date of this local law are hereby approved and the actions of the agency in establishing and collecting such fees and costs are hereby ratified.

§ 7. VALIDITY AND SEVERABILITY.

If any provision of this local law shall be judged invalid,

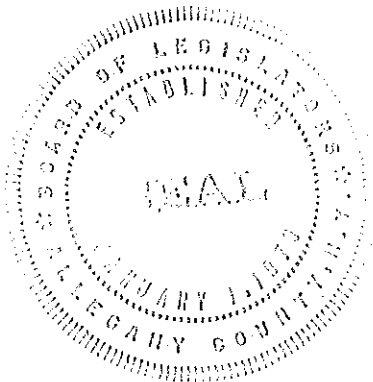
