

## 2024 General Financial Contribution Limits

**Family Limit: .25% X # of registered voters in district-if the number is below \$1,250 a family member can donate up to \$1,250.Larger districts such as the Legislative & County limits are higher as seen below.**

**Non Family Limit: .5% X # of registered voters in district-if the number is below \$1,000 a non family member can donate up to \$1,000. Larger districts such as the Legislative & County limits are higher as seen below.**
