

TITLE: ADOPTION OF LOCAL LAW INTRO. NO. 1-2002, PRINT NO. 1, TO AMEND LOCAL LAW NUMBER TWO OF NINETEEN HUNDRED NINETY-FOUR, AS AMENDED, TO REVISE AN EMPIRE ZONE (FORMERLY KNOWN AS AN ECONOMIC DEVELOPMENT ZONE)

RESOLVED:

1. That proposed Local Law, Intro. No. 1-2002, Print No. 1, is hereby adopted without any change in language, to wit:

A LOCAL LAW AMENDING LOCAL LAW NO. 2-94, AS AMENDED, TO REVISE AN EMPIRE ZONE (FORMERLY KNOWN AS AN ECONOMIC DEVELOPMENT ZONE)

BE IT ENACTED by the Board of Legislators of the County of Allegany, State of New York, as follows:

Section 1. By Local Law No. 2-94 this Board authorized a joint application for the designation of an Economic Development Zone relative to certain land with the Town of Friendship and the Village of Cuba in Allegany County.

Section 2. The Town of Friendship has received Economic Development Zone approval from New York State.

Section 3. That Local Law No. 2-94 was amended by Local Law No. 3-2001.

Section 4. It is the desire of this Board to concur with an application to revise the Economic Development Zone, now called an Empire Zone, to include land located in the Town of Wellsville, as more fully described in Section 5 of this Local Law.

Section 5. The boundary of the Empire Zone as described in Local Law No. 2-94, as amended, shall be revised to include properties in the Town of Wellsville, Allegany County, New York generally described as follows:

Section 6. The Commissioner of the New York State Department of Economic Development is hereby requested to revise the boundaries of the Empire Zone in accordance with this Local Law.

Section 7. In all other respect Local Law No. 2-94, as amended, shall remain in full force and effect.

Section 8. This local law shall be filed in the office of New York State Secretary of State upon the passage of amended local laws by Town of Friendship, Village of Cuba and County of Allegany, and the passage of supporting and concurring resolutions by the Town of Wellsville.

Section 9. The local law shall take effect upon filing in the office of New York State Secretary of State.
